


living conditions and to ensure a brighter future for themselves and their dependants. When this happens, we can all be rest assured that we have done our part in improving the living conditions of our people.

The principal function of the National Development Agency's (NDA) partnership model is to ensure the sustainability of funded development programmes and interventions through establishing and maintaining strategic partnerships with other private, government and donor organisations. The National Development Agency (NDA) was established with the sole mandate to contribute towards the country's efforts of eradicating poverty and its causes, which is intrinsically part of the triple challenges the country is confronted with namely: poverty, inequality and unemployment. Albeit the limited resources and the struggle to link the yields to markets or value chain constraints, the NDA has over the years worked with civil society organisations (CSOs) on poverty eradication efforts and its causes.

The NDA's new strategic focus aims to address the historic challenges by fine-tuning a focus that aims towards more legitimacy, credibility, social capital and control over funded interventions and programmes – including the closer monitoring of outcomes and the deliberate impact measurement of projects. Secondly, there is a need to upscale the existing funded projects to reach full stability and sustainability potential through aggressive resource mobilisation efforts amongst other various stakeholders in the development space delivering and responding to real community needs that are in alignment with the District Development Model framework.

Partnerships amongst business sector and non-governmental organisations or CSOs are common across the world in the form of corporate social responsibility initiatives and undertakings. This cross-sector collaboration pools resources, competencies and knowledge together for achieving greater impact in joint projects. It is against this backdrop that the NDA's partnership model considers partnership best suited to derive maximum benefit in depressed communities using CSOs as its vehicle. Effective collaborations and partnerships consider service delivery imperatives, cost effectiveness, social cohesion and nation building as well as the need to respond to demands of a constantly changing society that must deal with the effects of poverty, unemployment and inequalities.

NDA poverty eradication interventions are aligned with the recognition that people living in economic isolation have skills, wisdom, assets, capacities and productive entrepreneurial energy. The missing link is their need to access and transmit this potential into viable economic activity that uplifts communities through the creation of jobs and sustainable livelihoods.

The NDA calls on private, public and donor organisations who share in this philosophy, that collaborating with communities for their own development, which must be bottom-up, organic and people-driven, which is the only sustainable means to free communities of poverty, inequality and unemployment.

About KwaZulu-Natal

KwaZulu-Natal is located in the south-east of South Africa bordering the Indian Ocean. It also borders on the Eastern Cape, Free State and Mpumalanga provinces, as well as Lesotho, Swaziland and Mozambique. The 'Garden Province' of South Africa stretches from the lush subtropical east coast washed by the warm Indian Ocean, to the sweeping savanna in the east and the majestic Drakensberg Mountain Range in the west.

It covers an area of 94 361km², the third smallest in the country, and has a population of 11 065 240, making it the second most populous province in South Africa. The capital is Pietermaritzburg. The largest city is Durban. Other major cities and towns include Richards Bay, Port Shepstone, Newcastle, Estcourt, Ladysmith and Richmond.

The province's manufacturing sector is the largest in terms of contribution to GDP. Richards Bay is the centre of operations for South Africa's aluminium industry. The Richards Bay Coal Terminal is instrumental in securing the country's position as the second-largest exporter of steam coal in the world. The province has undergone rapid industrialisation owing to its abundant water supply and labour resources.

Agriculture is also central to the economy. The sugar cane plantations along the coastal belt are the mainstay of KwaZulu-Natal's agriculture. The coastal belt is also a large producer of subtropical fruit, while the farmers inland concentrate on vegetable, dairy and stock farming. Another source of income is forestry in the areas around Vryheid, Eshowe, Richmond, Harding and Ngome.

KwaZulu-Natal is divided into one metropolitan municipality (eThekwini Metropolitan Municipality) and 10 district municipalities (Amajuba, Harry Gwala, Ilembe, King Cetshwayo, Ugu, Umgungundlovu, Umkhanyakude, Umzinyathi, Uthukela and Zululand), which are further subdivided into 43 local municipalities.

COO's Message

The reality of our time is that many of our fellow country men and women live in poverty due to socio-economic conditions, not only in our country, but due to what is happening around the world. It is only through collectively addressing the issue of poverty, as government, state owned entities, private sector and the civil society sector, that we can address many ills that plague our respective communities.

We are called upon to be that generation that brings meaningful changes in the lives of marginalised societies. The truth is that, as the NDA, our programmes and projects can go far if all role players come together, through the District Development Model, to address socio-economic issues that keep our communities stuck in the circle of poverty.

The NDA has a wealth of experience in community development that transcends the different aspects ranging from strengthening the institutional capacity of CSOs, that implement development programmes and projects in poor communities, to assisting community-based organisations that provide community empowerment services or producing products that are traded in the community and beyond.

Programme 2, which I head, is the engine room of the NDA's primary mandate of contributing towards the eradication of poverty. It is in

Programme 2 that the NDA is represented in all the nine provinces across the country. Our provincial offices, inclusive of district offices where we have a footprint, are ready to work with partners and stakeholders that are committed to make a meaningful change in South Africa.

In the past, in executing our mandate, we used the CSOs Development Model, as approved in the 2016/17 financial year and which clearly provided a complete package of interventions to ensure members of the CSOs and their beneficiaries are: selected based on assessed needs and level of needs; provided with a combination of interventions pipeline for registration if not registered, capacity building, grant funding and linkages to markets and possible funders. This is to increase their own resources; and assist in attaining sustainability levels for the management of the CSO and the financial resources to support their programmes.

This approach was found to be inadequate to achieve the expectations of the NDA mandate, demonstrated by increased levels of poverty and unemployment. In 2021/22, the NDA had to initiate a process of turnaround and come up with a strategy that will effectively respond to the mandate of contributing towards poverty eradication. The new model is premised on targeting beneficiaries within indigent households which would be empowered to participate in community economic development initiatives through the District Development Model.

Our rich knowledge of community development puts us at the forefront of being catalysts and key players when it comes to

understanding projects and programmes that could make sustainable impact in the lives of people that both the public and private sector may want to invest in. The NDA works hand-in-hand, using the public and private partnerships, through its provincial offices and the civil society sector, to support community economic development initiatives whose main target is indigent households' members who have to be graduated out of poverty.

The NDA, over the years, has learned that development requires concerted efforts from all interested parties ranging from communities themselves, government, civil society, to the private sector. Communities have all the required assets that can form the foundation for investment and support to create community led development and sustainability.

The skills development programme, also in partnerships with the SETAs, private institutions and established CSOs, is aimed at strengthening emerging CSOs to ensure that they are able to produce quality services and products which will meet international standards that enable them to compete in the mainstream economy.

Provincial response to Poverty Eradication

The 2022/2023 financial year, was a critical period in which the revised Annual Performance Plan, key areas were evaluated, the progress was assessed and the performance was activated in a response to the findings of progress assessments. Generally, performance has been good and all targets were achieved, despite the budget constraints.

Resources Raised to fund CSOs Development Interventions

The province had an annual target of R1 660 000 and was able to raise resources to the value of R 2 919 564.92 from various national and provincial partners.

Number of poverty eradication projects funded by NDA

In 2022/23 19 Grant Funding Projects throughout KwaZulu-Natal were approved to the value of R2 479 649.65, compared to 2021/22, where 25 Grant Funded Projects were approved to the value of R 2 817 713.44. A further 6 CARA Projects to the value of R1 800 000 and 3 CSO Volunteer Programmes to the value of R 316 800 were approved in 2022/23. Contract signing and the induction of Grant Funded, CARA and Volunteer Programmes have been done and all programmes are currently at the implementation phase.

Work opportunities created as a result of CSOs development interventions

The province was able to create 381 work opportunities, thus exceeding the Annual target of 299 work opportunities through the NDA Grant Funding Programme, the CARA Programme and the CSO Volunteer Programme.

Number of CSOs capacitated with skills to implement poverty eradication projects

By the end of the 2022/23 financial year, the province had conducted capacity building interventions for 615 CSOs exceeding the annual target of 221. The 615 CSOs were trained in the following interventions: NPO and cooperative compliance, governance, financial management, conflict management, resources mobilisation and project management. Where there has been a need for technical training, the government and the private sector partnered and trained the CSOs in agriculture and manufacturing and other relevant skills.


The province is currently engaged to ensure more CSOs are capacitated effectively:

Background

The birth of Abalimi Cooperative can be credited to the Department of Agriculture that workshopped the young people in the Mpofana Local municipality to encourage them to start household gardens. The five friends decided to take the municipality's assistance and established a cooperative. "We had to start something because we were tired of staying at home. We had to contribute some funds to enable us to start the garden, along with the assistance from the Department of Agriculture", says Lizwilenkosi Ndlovu, Chairperson of the Cooperative.

The cooperative farms 4 of the 12 hectares zoned for agricuture leased from community members. They produce different crops like broccoli, cabbage, cauliflower and beans.

Since 2019, they have been harvesting just enough for their families and the local community. However, from 2022 they started selling their produce to retail shops and vendors as far as Escort and Pietermaritzburg.

NDA Intervention

The NDA grant went towards agricultural equipment and supplies which include: fencing, seedlings, protective clothing, sprinklers and draglines, fertilizers, herbicides and pesticides. Before the NDA's intervention the cooperative was farming only 1 hectare due to lack of equipment. The increase in hectares has ensured that they also increase the produce and profit. The NDA also trained their cooperative members on financial management, governance and resource mobilisation.

Immediate needs

The Cooperative needs a tractor, potato planter, maize planter and fencing. This will ensure that they save time and money as they have to hire this equipment. Sometimes they get the hired equipment late and it becomes very expensive.

Other partners

The Department of Agriculture is providing technical knowledge and skills to the cooperative. uMeda donated butternut and cabbage seedlings.

Background

"Although people with disabilities may require extra support performing their day-to-day duties, there are many things they can do to participate in the economy and uplift their lives while demystifying the disability stigma", explained Mrs Notsikelelo Phakane, the Chairperson of the Cooperative.

Mrs Phakane, who herself has been living with Poliomyelitis disability since she was a young girl due to Polio, is the founder of Mt Currie Disabled Women's Cooperative. The cooperative's focus is to ensure that they provide jobs to people with disabilities in

and around Kokstad. "We are a sewing cooperative and currently we produce school uniforms however, our goal is to be tracksuit specialists. We want the community and businesses to come to us when they need tracksuits", she said. In 2022, the cooperative acquired two contracts from the nearby schools to produce the school uniforms.

It is the primary focus of the cooperative to create awareness that disability is not inability. Three of the cooperatives' members are running other businesses and have contracts with SANRAL. Mrs Phakane says, "We want to encourage people with a disability to come out of their homes and participate in the economy. We believe that more support will come our way when government, private sector and other community members see us standing up for ourselves".

NDA Involvement

The grant went towards the procurement of sewing machines and materials to increase the production of school uniforms, tracksuits and other adult clothing. The grant was also used for the procurement of wheelchairs to improve the mobility and seating support of the two paraplegic members, the training of board members on governance and resource mobilization as well as capacity building and other interventions that the NDA offers.

Immediate Needs

The organisation is in serious need of transport and a proper housing facility. They also need technical skills to ensure that they produce high quality products, in order for them

Charlestown has a high rate of unemployment and dependency on social grants. According to Statistics South Africa Household Survey 2019, the area's dependency ratio is above 70%; as an average of 16.9% households are without an income. This is an area with a mere 3.4% of higher education for individuals aged 20 and above.

In response to the dire socio-economic challenges, Mr Jerome Ntombela, the chairperson of the cooperative introduced the idea of starting a cooperative to other members of the community who decided to join him in 2014. The cooperative was registered in 2015 and has 5 members. 4 females and a male.

"We wanted to create employment for ourselves so that we can increase the number

of people receiving income through the agriculture in our village. The area is good for potatoes, but the water shortages impact our work negatively. It slows down production. We are grateful that we received training from the Department of Agriculture to plant various crops depending on the season. However, potatoes are the crops that bring the highest returns", explained Mr Jerome Ntombela.

Even though the cooperative has around 2.5 hectares of land, they are currently only using 1 hectare and have plans in place to use the rest. Currently, the cooperative is producing potatoes, spinach, beetroot, onions, cabbage and mealies. They are also involved in goat and free-range chicken farming. The goat farming project will be resumed soon.

NDA Involvement

The NDA funded the project for land preparation, purchase of seedlings, garden tools, fertilisers and chemicals. The five cooperative members received capacity building to strengthen their day to day running of the cooperative.

Other Partners

Old Mutual donated a 4-ton truck to transport their crops to the various markets and a borehole to ensure consistent water supply for the cooperative. Other partners are SEDA, Amajuba TVET College and the Department of Agriculture.

Immediate Needs

Tunnels, irrigation system and fence.



Background

Silokoto is a black-owned cooperative that was established in 2011 by three women and two men who were responding to challenges facing their community, including unemployment and children who were orphaned because of the prevalence of HIV/Aids. Although the cooperative started in Umlazi they have now secured a bigger manufacturing space in Pinetown because of the success they had.

The initial plan was to produce clothing; especially school uniform and traditional clothing as a means of supporting their orphan and vulnerable programme. "We soon realised that this was a lucrative business where we can even employ more people", says Mrs Thandazile Gqwarhu, Silokoto's Chief Executive Officer. When the BEIER GROUP was looking to grow emerging black township companies in the textile industry in 2019, they saw the cooperative's potential and moved them to a manufacturing area in Pinetown. They also linked them with other strategic people to assist like ARENA TRIMS and WAK PTY LTD for mentorship and material supply.

Silokoto has graduated from producing in small scale to specialising in producing personal protective equipment and technical textile products. Toyota buys protective clothing from them. They are now also producing clothing for Foschini and other retail stores. They manufacture socks, thungs, superlasts and polybags that are used to make finished products like safety shoes.

NDA Intervention

The grant went towards buying machines that enable them to close the gaps and cut the middleman out in their production. They have saved time and money and have now increased the number of jobs.

Background

The impact of climate change is slowly creeping in, in South African. The KZN 2022 Floods were felt throughout the country. Mrs Thandi Shezi, Chairperson of Sivusa Sizwe Agricultural Primary Cooperative remembered their first visit to the farm after the floods. She said, "I could only put my trust in God, everything was gone, there was nothing. The situation was dire, some of us had to sell some of our properties to ensure that we get back on our feet".

The cooperative is now back on track, and they harvested the first produce which was green beans and spinach in December 2022. The profit was not as expected due to wet soil emanating from the floods. However, they managed to fence the 45 hectare farm, as it was posing as a security risk to their business.

The 5 member cooperative was registered in 2017. They realised that there was a gap in the fresh produce market because people were going to Richmond to get crops to sell in their area. They also took advantage of the fertile soil that grows fresh crops without difficulty. They pulled in their resources to buy the farm and start producing.

With their second planting after the floods, they increased the number of workers to 27. "I am proud that we also harvested 25000 cabbages now in April 2023". The cabbages were sold to the local Pick 'n Pay, Theo's Fruit & Veg, The People's markets, as well as the Durban Stokvel Market. "There is no shortage of the markets, we need to increase production from 20 hectares to use the farm to its full capacity", said Mrs Shezi.

NDA Involvement

The grant purchased a mobile water pump and the engine. The pump enabled the cooperative to increase production from just 10 hectares to 20 hectares, hence there is an increase of the jobs created from 12 to 27. They also bought office equipment. The NDA funding attracted other funders to come on board to assist the cooperative.

Immediate Needs

A tractor is a priority, pipes to connect the irrigation system and a vehicle to transport the produce.

Other Partners

Background

Five Domestic Workers turned seamstresses. "Domestic work was not giving us the work satisfaction we needed. We used to travel to work together, and a conversation started on what we would need to do to get what we want. We had little knowledge of sewing and beading but we were interested to learn", said Mrs Busisiwe Gamede, Chairperson of the Cooperative.

In 2012, the five ladies started to crochet hats and scarves on weekends while they were still working as domestic workers. They each contributed money to buy materials and three domestic sewing machines. Mrs Gamede had some sewing knowledge; she trained the others. They were self-taught on bead work. They produced all sorts of designs, however, they chose to focus on school uniform as they saw a market gap.

They are the sole producers of school uniform for four schools and two ECD Centres in Craigside Township. They operate at Talana Museum, so their beadwork is sold to the tourists who visit the museum.

The cooperative has been doing well regardless of the social ills in the community such as theft, substance abuse, high unemployment and poverty. Covid-19 impacted their production terribly, since the schools were not ordering any uniforms. "We are getting back to normal, we even hired two more people to assist us since we were not able to finish our orders on time", said Mrs Gamede.

NDA Involvement

The grant went towards purchasing the embroidery, buttonholes and button sewer machines. They already had two industrial machines that were donated by Buffalo Coal in 2017. The NDA also trained the cooperative on Bookkeeping and Cooperative Act Compliance. These machines have increased productivity of the cooperative and its income, as they also use them for other people who would want to do bulk embroidery services for a fee. The NDA trained the Cooperative in Project Management and Resource Mobilisation.

Immediate Needs

The number of formal contracts with schools and other business so that they are sustainable, needs to be increased. The Cooperative also needs a laptop for the embroidery machine.

Other Partners

SEDA paid for fashion design training while the Department of Agriculture trained the cooperative in business management. The Talana Museum is hosting the cooperative in their premises for a rental of R350 per month. Endumeni Local Municipality purchased the sewing machine and fabric for the Cooperative.
