Must the pricing be for 36 months or can suppliers give costing for a year only?	Pricing must be for the total number of the duration of the contract which is 36 months, including VAT and escalations.			
Does NDA foresee any user growth over the 36 months?	Not at the moment, any growth will be after the 36 months.			
Are there any ad-hoc or historic emails already archived or is there a need to ingest old emails?	Archiving and ingestion has already been done.			
How many persons/users are permitted to log calls with Mimecast from the NDA side?	One (01) person is permitted to log calls with Mimecast.			
In terms of the infrastructure, are there any changes that will be adopted in the next three (03) years?	NDA is currently on windows 365 hybrid configuration. No additional work will be required and only the renewal of the contract is required as previously explained.
